## EMERGENCY FOOD ASSISTANCE PROGRAM, A PROGRAM OF MAMA'S PANTRY

In 2015, Mama's Kitchen established an Emergency Food Assistance program for HIV+ residents of San Diego County. Emergency food bags were distributed to 9 clients. Eligible participants receive up to 12 weekly grocery bags in a 12-month period, each containing perishable and nonperishable food items equivalent to 21 meals or one week of groceries.

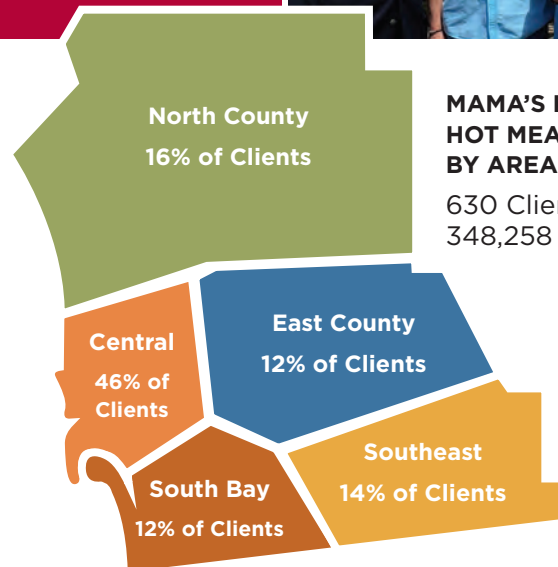

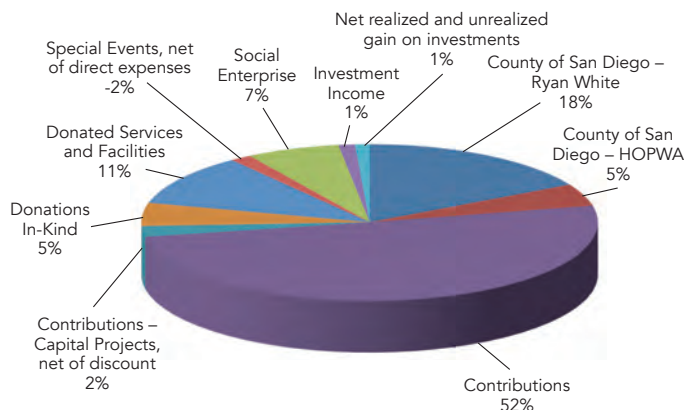

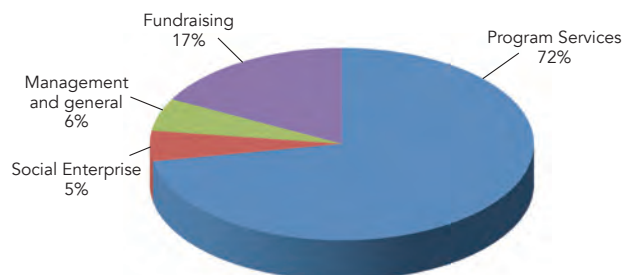
